**Public Health Sudbury & Districts works with Public Health Ontario to follow-up with close contacts of COVID-19 cases. Public Health Ontario does not customize direction based on local investigations. Local direction is based on individual circumstance and risk assessment, after detailed follow up and is based on a number of factors (such as vaccination status, breakthrough cases, and Variants of Concern). If you receive conflicting information on your isolation, please follow the directions in this letter.**

Dear Parent/Guardian, Student, Staff: **Grade 5A**

An individual who attended **École St-Pierre** in **Grade 5A** has tested positive for COVID-19 and your child/student/staff has been identified as a potential close contact.

Someone is considered a close contact if there is a chance that they had a high-risk exposure to someone who tested positive for COVID-19.

Public Health Sudbury & Districts has investigated and determined that the last date of high-risk exposure was **November 5, 2021**.

If the child/student/staff has or develops any of the following symptoms, they should get tested as soon as possible.

- Fever and/or chills (temperature of 37.8 degrees Celsius/ 100 degrees Fahrenheit)
- Cough or barking cough (croup)
- Shortness of breath
- Decrease or loss of taste or smell
- Nausea, vomiting and/or diarrhea
- Fatigue
- Muscle aches and pain
- Sore throat
- Runny or stuffy nose
- Abdominal pain
- Headache
- Conjunctivitis (pink eye)
- Decreased or lack of appetite

**Based on this investigation, Public Health has concluded that direction will be based on an individual's immunization status. If the isolation period changes or is extended, you will be notified by letter.**

Please carefully review the following direction for those who are **fully immunized** (or previously positive) and the direction for those who are **NOT fully immunized** (or immunization status unknown or not previously positive). Please follow the scenario applicable to your situation.

### **Fully immunized (or previously positive): Public Health direction**

If the child/staff is not immunocompromised and has been **fully immunized** for COVID-19 or was a **confirmed positive** case within the last 90 days, this section applies to them.

<sup>1</sup>An individual is **fully immunized** if at least 14 days prior to their high-risk exposure they have received:

- the full series of a COVID-19 vaccine authorized by Health Canada, or any combination of such vaccines; OR
- one or two doses of a COVID-19 vaccine not authorized by Health Canada, followed by one dose of a COVID-19 mRNA vaccine authorized by Health Canada; OR
- three doses of a COVID-19 vaccine not authorized by Health Canada.

<sup>2</sup>An individual is considered **previously positive** if they tested positive for COVID-19 in the last 90 days and have since been cleared from their infection.

**NOT fully immunized (or immunization status unknown or not previously positive):**  
**Public Health direction**

If the child/staff is immunocompromised or has **NOT been fully immunized<sup>3</sup>** or was **not a previously positive<sup>4</sup>** case within the last 90 days, this section applies to them.

<sup>3</sup>An individual is **not fully immunized** if at least 14 days prior to their high-risk exposure they have **not** received:

- the full series of a COVID-19 vaccine authorized by Health Canada, or any combination of such vaccines; OR
- one or two doses of a COVID-19 vaccine not authorized by Health Canada, followed by one dose of a COVID-19 mRNA vaccine authorized by Health Canada; OR
- three doses of a COVID-19 vaccine not authorized by Health Canada.

<sup>4</sup>An individual is **not previously positive** in the last 90 days if they have not tested positive for COVID-19 in the last 90 days and been cleared of their infection.

| <b>When can the child/staff return to school/work?</b> | If they test positive, Public Health will contact you to provide additional information on return to work/school.<br><br>If they test <b>negative</b> , and provided no new or worsening symptoms, they can return on <b>November 16, 2021</b> , as long as they have no fever and symptoms have been improving for at least 24 hours, or 48 hours for gastrointestinal symptoms (for example: vomiting, diarrhea).  |   |
| <b>Do household contacts need to self-isolate?</b>     | Household members who are <b>fully immunized<sup>1</sup></b> or <b>previously positive within the past 90 days<sup>2</sup></b> are <b>not required</b> to self-isolate, as long as the household member themselves does not develop symptoms.<br><br>Household members who are <b>not fully immunized<sup>3</sup></b> and not <b>previously positive within the past 90 days<sup>4</sup></b> :<br><ul style="list-style-type: none"> <li>• Must isolate while the child is awaiting their test results.</li> <li>• Must isolate if the child tests <b>positive</b>.</li> <li>• Can stop isolating if the child tests <b>negative</b>, but should stay home except for essential reasons (school, work, child care).</li> </ul> | Household members who are <b>fully immunized<sup>1</sup></b> or <b>previously positive within the past 90 days<sup>2</sup></b> are <b>not required</b> to self-isolate, as long as the household member themselves does not develop symptoms.<br><br>Household members who are <b>not fully immunized<sup>3</sup></b> and who were <b>not previously positive<sup>4</sup> within the past 90 days</b> should stay home except for essential reasons (school, work, child care) if the child is <b>asymptomatic</b> OR tests <b>negative</b> . |

Call 911 or take your child to the nearest hospital immediately if your child is experiencing any of the following symptoms:

- Severe difficulty breathing (struggling for each breath, can only speak in single words)
- Severe chest pain (constant tightness or crushing sensation)
- Feeling confused or unsure of where they are
- Losing consciousness
